

Abstract: The Pennsylvania Department of Transportation (PennDOT) and the Federal Highway Administration are undertaking a long-term, multiphase project to improve and rebuild I-95 in Pennsylvania. Using an innovative approach, a programmatic agreement (PA) was designed to meet design and construction schedules for a 3-mile segment referred to as GIR and provide significant cost savings—which it has. All parties that signed the PA agreed that 17th- through early-20th-century domestic and industrial deposits, if found intact, would be significant. All parties agreed that any intact Native American sites would also be signif-

icant. But the PA provided for much more, especially in terms of the immediate dissemination of information to a technologically savvy, 21st-century audience. The local component of this audience can't get enough of their neighborhoods' past and have become so engaged with the project that I-95 construction and design issues are no longer the focus of public interest. In this session, AECOM will present our comprehensive sustainable public outreach program through several talks focusing on household and individual genealogy; journals, postcards, calendar, and playing cards; pop-up museums and short- and long-term exhibits; field excavation tours; technology (hololens, 3D printing/scanning, walking tour app); and neighborhood project lab and long-term public displays.

Nelson, Reid J.

Director, Office of Federal Agency Programs, Advisory Council on Historic Preservation

Reid became the director of the Advisory Council on Historic Preservation's (ACHP) Office of Federal Agency Programs (OFAP) in 2009. OFAP is principally responsible for carrying out the ACHP's oversight of the Section 106 review process as established by the

National Historic Preservation Act of 1966. As director, Reid oversees the ACHP's participation in Section 106 reviews as well as its efforts to develop program improvements and provide technical assistance and guidance to Section 106 users. He also oversees the ACHP's training program designed to improve federal agency and stakeholder understanding of the Section 106 review process. Leading up to his position as director, he worked in OFAP for three years as the assistant director for Federal Property Management. Prior to coming to the ACHP, he worked with the Navajo Nation in its Archaeology and Historic Preservation Departments for 18 years, the last nine of which were as a program manager for the Navajo Nation Historic Preservation Department. He has also lectured, researched, and worked in cultural resource management across the western United States.

Banks, Kimball, Ph.D.

Director of Strategic Development, Metcalf Archaeological Consultants, Inc.

Dr. Kimball Banks has 40 years of experience in cultural resource management, 26 in the federal sector and 14 in the private sector or university setting. Kimball received his Ph.D. in archaeology from Southern Methodist University in 1984 and has conducted fieldwork in California,

the Southwest, Texas, the Southeast, and the Northern Plains. In addition, he has worked in Oman and Egypt. In the federal sector, Kimball first worked as Forest Archaeologist in the Navajo Area Office and then as Area Archaeologist in the Northern Plains Regional Office of the Bureau of Indian Affairs. Subsequently, he was Area Archaeologist and Native American Affairs Specialist in the Dakotas Area Office and the Tribal and Financial Assistance Officer in the Great Plains Regional Office of the Bureau of Reclamation. Since 2009, he has been employed by Metcalf Archaeological Consultants, Inc. Kimball is a member of ACRA's Government Relations Committee and SAA's Media Relations Committee, is on the editorial board for Advances in Archaeological Practice, and recently was selected to chair the Excellence in Cultural Resources Management Award Committee for SAA. Kimball has authored numerous articles and was co-compiler and editor on two recently published books: one on the River Basin Surveys and the other on the National Historic Preservation Act that commemorates its 50th anniversary.

Dr. Barile has 25 years of experience in the fields of historic preservation, architectural history, historic research, archaeology, and CRM. She received her B.A. in Historic Preservation from Mary Washington College in Fredericksburg, a M.A. in Anthropology and a Master's Certificate in Museum Management from the University of South Carolina, and a Ph.D.

in Archaeology and Architectural History from the University of Texas at Austin. She co-founded Dovetail Cultural Resource Group in 2005. She is also on the ACRA Board and serves as the ACRA Conference Committee Chair. In addition to CRM experience, Dr. Barile continues to pursue her interests in local historic preservation initiatives through a variety of activities. She teaches university courses in historic preservation and preservation law, architectural history, and archaeology, and she regularly volunteers for communities and non-profit preservation groups. She serves on the Fredericksburg Architectural Review Board and she was also selected as a member of the City's Historic Preservation Task Force, where she was the primary author on the City's Historic Preservation Plan. Dr. William Chadwick is an archaeological geophysicist and geoarchaeologist, who conducts research on landscape and environmental change related to historic and prehistoric archaeological sites. Dr. Chadwick holds a Ph.D. in Geology from the University of Delaware, where he

gained extensive training in archaeological geology, ground-penetrating radar (GPR), quaternary geology, sedimentology, stratigraphy, and geomorphology. His experience in archaeology includes all phases of excavation related to prehistoric and historic period sites throughout the Mid-Atlantic and New England regions. Dr. Chadwick's research interests include archaeological geophysics, intertidal archaeology, and the application of geospatial technology to archaeology.
